By post: To reach the Head Supply Chain Management, Private Bag X5, Barkly West, 8375, in sufficient time for it to be placed in the Tender box before closing time.

The following conditions apply (Failure to attach will lead to disqualifications):

- ✓ Bids must only be submitted on the bid document provided by the Dikgatlong Local Municipality
- ✓ Persons in the service of the state are not allowed to bid
- ✓ Attach original certified ID documents
- ✓ Original Certified Company Registration forms
- ✓ Bidders are requested to attach their recent municipal accounts of the company not in arrears for more than 90 days and/or lease agreements in the case where the company rents
- ✓ Attach copy of Tax Clearance Pin obtainable from SARS
- ✓ Current CSD Registration forms to be attached not older than 30 days
