BACKGROUND AND SPECIFICATIONS/ SCOPE OF WORK

Operating Regulations for high voltage systems (ORHVS) regulates rules and responsibilities for person responsible for authorized for switching ON and OFF on power line. The regulations aim to empower a designated person and provide guide on standard operating procedures on MV and HV power lines. The assign qualified authorized person can accept work permits, risks assessment, power isolation and earthing apparatus.

ORHVS training further guide on the access and supervision of isolation and inspections circuits, live chambers and prohibiting areas, operating principles, Abnormal Conditions and Exceptions to the General Rule. Use of operating instruction form and commissioning and testing. ORHVS promotes safety standards above all through proper risk assessment and safety analysis to ensure continuity of safe supply.

Currently Dikgatlong Municipality does not have such skills. Municipality depends on calling Eskom Control at Bloemfontein to dispatch someone from Eskom in Barkly West to isolate on their behalf. In terms of electrical norms and standards the electricity department is not complying with minimum electrical basic regulations. No duly assigned authorized person for switching power lines, responsible to issue work permits or authorized to work on power lines, mains switches or live chambers.

This bid is subject to the General Conditions of Contract and, if applicable, any other Special Condition of Contract.
3. Quotes must be valid for a period of 30 days

4. Suppliers must submit their quotes with the following documentation and or information:

4.1 A valid original Tax Clearance certificate or a valid tax pin.

4.2 A certificate certifying that the bidder has no undisputed commitments for Municipal services

towards a municipality or service provider i.r.o. payments which are overdue more than 90 days; if the bidder is the lessee a valid lease agreement together with the municipal account of the landlord; or a letter from tribal authority if the service provider operates in rural area.

4.3. Certified evidence of B-B.B.E.E. contributor status by SANAS, IRBA or SANAS accredited agencies or valid affidavit order to claim HDI points.

4.4. MBD 4, 6.1, 8 and 9 must be fully completed and submitted together with a quotation.

4.5. Bidders must be registered on the Central Supplier Data Base.

4.6. The tender will be evaluated in terms of the 80/20 preference points system of which 80 points will be for price and 20 points for specific goals (HDI and Locality) as illustrated below.
