**BID NO: RFQ04/2024/25**

Dikgatlong Municipality hereby invites suitably prospective service providers to quote for water tankering services on an as-and-when basis depending on the needs. Sealed Price quotations clearly marked “**RFQ04/2024/25 WATER TANKERING SERVICES ON AN AS-AND-WHEN BASIS**” endorsed on the envelope” must be submitted to the Dikgatlong Local Municipality, 33 Campbell Street, Barkly West, 8375. Bids must reach the municipality before 12h00 on Thursday the 25th of July 2024.

### **BACKGROUND AND SPECIFICATIONS/ SCOPE OF WORK**

The Department of Water and Sanitation has provided water tanks to Dikgatlong Municipality during the Covid 19 pandemic. Unfortunately, the municipality could not connect all these water tanks to our networks especially in the rural areas and many of those in the informal settlements.

We therefore need a water tankering service provider available on an as-and-when needed basis. The minimum preferable size for the water tankers must be 12,000 litres. The water tankers will be required to deliver water to all the communities in Dikgatlong municipal areas, including filling of “Joj-jo” tanks. The request will give us an option to procure the number of tankers as per the need of the municipality at any stage.

The areas include:

- Barkly West
- Delpoortshoop
- Windsorton
- Smithmine (Rural)
- Spitskop (Rural)
- Holpan (Rural)
- Pniel Estate (Rural)
- Cottonsfield (Rural)
- Gong-gong (Rural)
- Keisikamma (Rural)

The water supply points from which water has be collected from is about 40 km from Barkly West. It is expected that the tanker will travel a minimum of 320 km daily. The specific delivery areas will be indicated to the service per request/order provided.

**It is required that the service providers quote on a daily rate for an 9-hour day per tanker.**

1. Late, emailed, faxed, incomplete quotes will not be considered.
2. All quotes will be adjudicated and awarded in terms of the Dikgatlong Local Municipality Procurement and Supply Chain Management Policy, the Preferential Procurement Policy Framework Act, Act No. 5 of 2000 and the regulations promulgated under this Act. This bid is subject to the General Conditions of Contract and, if applicable, any other Special Condition of Contract.
3. Quotes must be valid for a period of 30 days.

**4. Suppliers must submit their quotes with the following documentation and or information:**

4.1 A valid original Tax Clearance certificate or a valid tax pin.

4.2 **A certificate certifying that the bidder has no undisputed commitments for Municipal service**

towards a municipality or service provider i.r.o. payments which are overdue more than 90 days; if the bidder is the lessee a valid lease agreement together with the municipal account of the landlord; or a letter from tribal authority if the service provider operates in rural area.

- 4.3. ID copies of the directors/ shareholders in order to verify information for claiming of HDI points.
- 4.4. MBD 4, 6.1, 8 and 9 must be fully completed and submitted together with a quotation.
- 4.5. Bidders must be registered on the Central Supplier Data Base.
- 4.6. The tender will be evaluated in terms of the 80/20 preference points system of which 80 points will be for price and 20 points for specific goals (HDI and Locality) as illustrated below.
