The completed Tender documents must be placed in the Tender Box, situated at the main reception area of Dikgatlong Local Municipality, 33 Campbell Street, Barkly West, 8375, no later than **12 December 2024 at 12h00**. Details of all bids received will be posted on the municipal website ([www.dikgatlong.gov.za](http://www.dikgatlong.gov.za)). Dikgatlong Local Municipality will not be issuing letters to unsuccessful bidders; however, it is the responsibility of the bidders to visit the municipality website to obtain such information.

**Bids may only be submitted on the original documentation by Dikgatlong Municipality.**

Tenderers are required to submit a municipal account bearing the Tenderers Entity's name as proof of payment of municipal services which is not older than 3 month and must not be in arrears for more than 3 months at the tender closure date.

Telephonic, facsimile, email and/or late bids will not be accepted. Bids must be valid for a period of ninety (90) days after the closing date of the bid. The tender will be evaluated in terms of the 80/20 preference points system of which 80 points will be for price and 20 points for specific goals (HDI and Locality) as illustrated below.
