- ✓ Bids must only be submitted on the bid document provided by the Dikgatlong Local Municipality
- Persons in the service of the state are not allowed to bid
- ✓ Attach certified ID documents and Certified Company Registration forms
- Bidders are requested to attach their recent municipal accounts of the company not in arrears for more than 90 days and/or lease agreements in the case where the company rents
- ✓ Attach copy of Tax Clearance Pin obtainable from SARS
- ✓ CSD Registration forms to be attached not older than 30 days
- The bids will be evaluated and adjudicated in terms of functionality assessment as stipulated in the Terms of reference, Preferential Procurement Policy Framework Act No.5 of 2000, Preferential Procurement Regulation 2017, Municipal Supply Chain Management Regulations and Supply Chain Management Policy of the Dikgatlong Local Municipality.
